Why invest in Royce Small/Mid-Cap Premier Fund?

- Small/mid-cap core fund (generally market caps up to \$15 billion) that invests primarily in what Royce believes are industry leaders with discernible competitive advantages, high returns on invested capital, and a sustainable, moat-like franchise
- Focuses on leading quality companies, those with sustainable, moat-like franchises, discernible competitive advantages, a history of prudent capital allocation, and opportunities to profitably reinvest excess cash flow
- Averaged a 10.3% return over all 154 10-year monthly rolling return periods ended 9/30/18 from inception (12/27/95)

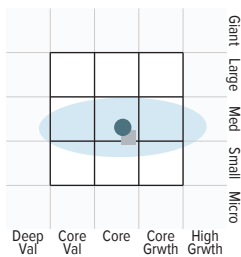

As of 6/30/18

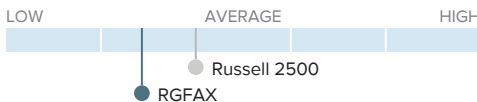

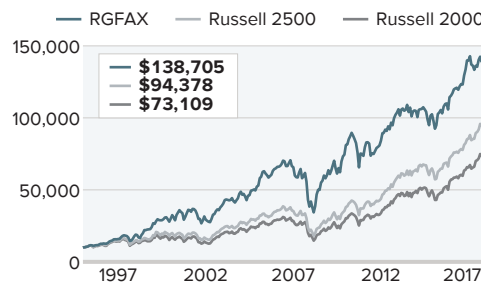
Below Average Volatility³ As of 9/30/18

1. Royce classifies the Fund as 'Core' because it anticipates the portfolio will have a weighted average price-to-book ratio or weighted average normalized price to earnings ratio that is similar to, or somewhat higher than, the Russell 2000 Index. 2. **Geometric Average.** This weighted calculation uses each portfolio holding's market cap in a way designed to not skew the effect of very large or small holdings; instead, it aims to better identify the portfolio's center, which Royce believes offers a more accurate measure of average market cap than a simple mean or median. 3. **Below Average Volatility.** The Fund was in the second-lowest volatility quintile compared with all funds in Morningstar's Small Growth, Small Blend, Small Value, Mid-Cap Growth, Mid-Cap Blend, and Mid-Cap Value Categories with at least five years of history, a total of 931 funds as of 9/30/18. The universe consists of each fund's oldest share class only. Volatility quintiles are based on the average five-year standard deviation for each of the last four calendar quarters. Higher volatility is usually associated with higher risk. 4. **Active Share** is the sum of the absolute values of the different weightings of each holding in the Fund versus each holding in the benchmark, divided by two. 5. **Harmonic Average.** This weighted calculation evaluates a portfolio as if it were a single stock and measures it overall. It compares the total market value of the portfolio to the portfolio's share in the earnings or book value, as the case may be, of its underlying stocks. 6. The Fund's P/E Ratio calculation uses trailing 12-month earnings and excludes companies with zero or negative earnings (0% of portfolio holdings as of 9/30/18).

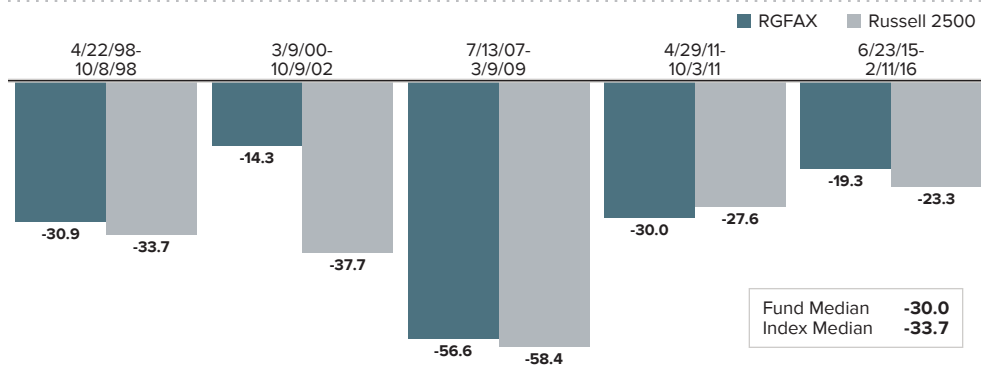

Down Market Performance Comparison (%)

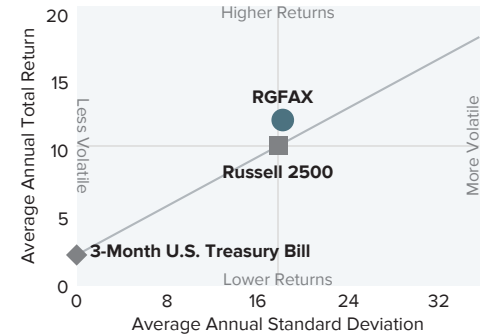
The Fund outperformed the Russell 2500 during four out of five downturns of 15% or more from the index's prior historical high since the Fund's inception.

Market Cycle¹ Performance (%)

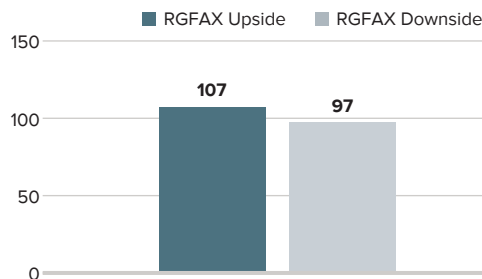
The Fund outperformed the Russell 2500 in two of the three most recent full market cycle periods.

The **Price-Earnings**, or P/E, Ratio is calculated by dividing a company's share price by its trailing 12-month earnings-per-share (EPS). The **Price-to-Book**, or P/B, Ratio is calculated by dividing a company's share price by its book value per share. **Standard deviation** is a statistical measure within which a fund's total returns have varied over time.
